<sup>\*</sup> Student Fees cover costs incurred for every student that are consumable, fixed, prepaid and non-recoverable by Plymouth Christian Academy. Costs vary by grade due to the differing expenses/needs for the offerings provided. For this reason, Student Fees are broken out separately from Tuition and are non-refundable to families.

# 2024-25 TUITION INFORMATION & POLICIES

- ➤ <u>All tuition and fees are paid via electronic transfer through FACTS Tuition Management</u>. Families access their account information through FACTS Family Portal, a secure, custom site. Contact Laura Imlach in the Tuition Office at 734-459-3505 x 3156 if you have any questions.
- Tuition is payable by the following options:
  - <u>Full payment</u> (tuition and fees): Due on or before May 31, 2024 for current students, or within 30 days of acceptance for new students. Payment is made electronically through the FACTS program. Payments may be made through checking or savings accounts, or credit card: Visa, MasterCard, Discover, American Express. If full payment is made, a pre-payment discount is offered.
  - <u>Semi-annual payment</u> (tuition and fees): Families may prepay by semester if larger lump sum payments are a better fit for their budget needs. First semester payment, which is 50% of the total balance due, must be paid before the first day of school. The remaining 50% balance due must be paid before the start of second semester. This timing is a requirement and cannot be adjusted.
  - **Monthly payment** (tuition and fees): Monthly, **no interest** payments will be made by electronic transfer through the FACTS program. There are several options including:
    - Method of payment (checking, savings, credit card)
    - o Payment dates (i.e., 5<sup>th</sup>, 10<sup>th</sup>, 15<sup>th</sup>, 20<sup>th</sup> or last day of each month)
    - Length of payment terms:
      - Payment plans for <u>current</u> families run 10-months (beginning in July) or 11-months (beginning in June); <u>New</u> families must start payment plans within 30 days of enrollment with first payment made before attending class(es).
      - All payment plans for the 2024-25 school year must be completed by April 30, 2025.

A student's account must be current by the first day of school, and at least ½ the balance must be paid off by end of Semester 1 to continue attending school. For monthly payment plans, the first payment must be made by July 31<sup>st</sup> (current families) or before the first day of school/attending class(es) for new families. By graduation or time of withdrawal, the account must be current to complete graduation/receive student records or current transcript.

Returned checks will carry a \$30 processing fee.

<u>Records and transcripts</u> will be forwarded to another school or college for students whose tuition, fees, and fine accounts are current. An "Incomplete" will be applied to a student's courses if his/her account is not current.

# **FACTS Policies:**
