TUITION DISCOUNTS

Prepayment Discount.	2.5% discount if payment received before May 31, 2026 (current families) or within 30 days of enrollment (new families)
Multiple Child Discount.	2% discount for 2 nd child enrolled 10% discount for 3 rd child enrolled 50% discount for 4 th child+ enrolled
CBC Member Discount.	20% discount for CBC Members in good standing; application required for consideration
Full Time Ministry Discount	Discount for full-time ministry personnel; application required for consideration
Financial Aid for qualified families.	Available for full-time students enrolled in grades 5-day K to 12 th ; application required for consideration

** Student Fees cover costs incurred for every student that are consumable, fixed, prepaid and non-recoverable by Plymouth Christian Academy. Costs vary by grade due to the differing expenses/needs for the offerings provided. For this reason, Student Fees are broken out separately from Tuition and are non-refundable to families.*

2026-27 TUITION INFORMATION & POLICIES

- ☑ All tuition and fees are paid via electronic transfer through FACTS Tuition Management. Families access their account information through FACTS Family Portal, a secure, custom site. Contact Laura Imlach in the Tuition Office at 734-459-3505 x 3156 if you have any questions.
- ☑ Tuition is payable by the following options:
 - **Full payment** (tuition and fees): Due on or before **May 31, 2026** for current students, or within **30 days** of acceptance for new students. Payment is made electronically through the FACTS program. Payments may be made through checking or savings accounts, or credit card: Visa, MasterCard, Discover, American Express. If full payment is made, a pre-payment discount is offered.
 - **Semi-annual payment** (tuition and fees): Families may prepay by semester if larger lump sum payments are a better fit for their budget needs. First semester payment, which is 50% of the total balance due, **must be paid by July 31st (current families) or before attending classes (new families).** The remaining 50% balance due **must be paid before the start of second semester, January 15th.** This timing is a requirement and cannot be adjusted.
 - **Monthly payment** (tuition and fees): Monthly installment payments will be made by electronic transfer through the FACTS program. **PCA does not charge interest for paying in installments.** There are several options including:
 - Method of payment (checking, savings, credit card)
 - Payment dates (i.e., 5th, 10th, 15th, 20th or last day of each month)
 - Length of payment terms:
 - Payment plans for current families run 10-months (beginning in July) or 11-months (beginning in June); New families must start payment plans within 30 days of enrollment with first payment made before attending class(es). New families may select the longest available plan at the time of enrollment.
 - **All payment plans for the 2026-27 school year must be completed by April 30, 2027.**

A student's account **must be current** by the first day of school, and at least ½ the balance must be paid off by end of Semester 1 to continue attending school. For monthly payment plans, the first payment must be made by July 31st (current families) or before the first day of school/attending class(es) for new families. By graduation or time of withdrawal, the **account must be current to complete graduation/receive student records or current transcript.**

Records and transcripts will be forwarded to another school or college for students whose tuition, fees, and fine accounts are current. An "Incomplete" will be applied to a student's courses if his/her account is not current.

FACTS Policies:

- FACTS charges a one-time annual set-up fee paid at the time of the first payment; this fee is per payment plan (not per student) and is paid to FACTS, not PCA.
- Most banks charge a fee for Non-Sufficient Funds (NSF); In addition, FACTS charges a \$25 NSF fee
